# **Bathroom Raffle Terms and conditions**

General terms and conditions which apply for a raffle

Our raffle will raise essential funds for people living with dementia, their careers and families in Scotland. Detailed records about our raffle are kept securely under GDPR regulations by our Stakeholder Engagement Team and may be provided to the gambling commission on their request.

All profits from the Bathroom raffle 2021 will be donated to Alzheimer Scotland (registered charity no. SC022315).

The person/s responsible within Alzheimer Scotland for the promotion of the Bathroom Raffle 2021 is Stakeholder Engagement Team, 81 Oxford Street Glasgow G5 9EP.

Based upon our estimates for our first raffle we predict the average the chance of winning a prize for a single ticket is approximately 1 in 1,667
Based upon our estimates of the number of entries and our costs for this Raffle, we estimate that approx 32% will be spent on expenses, 0% on prizes and 68% will be available to the Charity to fund our work

# **Key Terms**

The information set out below is a summary of our key terms for information purposes only. This does not replace the full terms and conditions set out below. In the event of any conflict between this summary and the full terms and conditions, the full terms and conditions will apply.

- (A) You must be 16 years of age or older and meet the other eligibility and verification criteria to purchase a Raffle Ticket or receive a Prize. See Clauses 1, 7 and 27.
- (B) Each Raffle Ticket will be sold for £1.
- (C) Applications for Raffle Tickets received after **23:59** on **29 march 2021** will not be entered into the Bathroom Raffle 2021 and the payment for such Raffle Tickets will be treated as a donation to Alzheimer Scotland unless you expressly state otherwise on your application for such Raffle Ticket(s).
- (D) The Prizes for the Draw are: (Ist Prize) Wet wall bathroom supplied and fitted. Full breakdown of what's included in the package will be detailed in section 20. (2nd Prize), Michael Kors bag £225 (3rd Prize), headphones are AKG by Harman Headphone model Y50BT from John Lewis cost £115
- (F) Any complaints or disputes will be first handled by Stakeholder Engagement Team with a right to appeal to the Fundraising Standards Panel. See Clauses 41-43.

### **Definitions:**

- 'Bathroom Raffle 2021' (means lottery), which consist of the Main Draw and some runner up prizes. The main draw prize has been donated by Wet Wall Bathrooms, Glasgow and Ayrshire and they reserve the right to offer installation to South, West and East of Scotland only, which will exclude the North. (The North of Scotland being anywhere from Perth upwards and the Highlands and Island are excluded in this raffle.)
- 'Closing Date' means **23:59 on 29 March 2021** for entries by digital on-line ticket sales only
- 'Ticket Holder' means a person who holds a Raffle Ticket in accordance with these terms and conditions.

# **Entry Conditions**

- a) 1. To be eligible to purchase a Raffle Ticket, a person must:
  - a) be 16 years of age or over;
  - b) located in East, West or South Scotland; This excludes From Perth upwards and also excludes the Highlands and Island
    - c) not be an employee of Alzheimer Scotland
    - d) comply with these terms and conditions.
    - e) self-certify that they are the required age to play. A confirmation email will be sent to the entrant confirming their numbers in the draw and thanking them for their participation. Random age verification checks are carried out at regular intervals. If an entrant is found to be under the required age their payment will be returned, and they will not be entered into the draw.
    - f) Not buy entries on behalf of someone else

Material changes to this raffle are not predicted to happen, but in the event that this occurs you will be notified by email 14 days in advance of any changes

- 2. A Raffle Ticket will be entered into the Bathroom Raffle 2021 if:
- a) an application for such Raffle Ticket is received by the Alzheimer Scotland before the Closing Date: and
- b) payment for such application is received by Alzheimer Scotland before the Closing Date.
- 3. Each Raffle Ticket will be sold for £1.
- 4. Alzheimer Scotland may, at its sole discretion, refuse to sell a Raffle Ticket to any person without giving reasons
- 5. A Raffle Ticket may not be transferred from a person listed as the owner of the respective Raffle Ticket on Alzheimer Scotland records to another person.
- 6. By purchasing a Raffle Ticket, you agree to provide a minimum of your e-mail, Full name, house number, street name, contact number and postcode. Your personal data will only be used in order to contact you if you have won a Prize and if you agree permission under GDPR. Options to be contacted in the future will be

# **Underage purchases**

- 7. By purchasing a Raffle Ticket or entering you confirm that you are 16 years or older at the date when you purchased the Raffle Ticket Draw. If Alzheimer Scotland determines that a Ticket Holder is under the age of 16 at the date the Raffle Ticket was purchased, the Ticket Holder shall not be entitled to any Prize and Alzheimer Scotland will return to the Ticket Holder the amount paid by them the Raffle Ticket(s).
- 8. Alzheimer Scotland reserves the right to verify the age of any person seeking to purchase a Raffle Ticket or a Ticket Holder, at any time (including after a Raffle Ticket has been purchased), by requesting such proof of age as Alzheimer Scotland may require.

# **Payment**

- 9. By purchasing, or attempting to purchase, a Raffle Ticket, you agree to be bound by these terms and conditions.

- 11. Credit cards cannot be used

# **Closing Date**

- 14. The Closing Date for the Bathroom Raffle 2021 purchased online is **23:59 on 29 March 2021**.
- 15. Applications for Raffle Tickets received after the 29 March at 23:59 will not be included in the draw.
- 16. Any payment for Raffle Tickets received after the Closing Date will be treated as a donation to the Alzheimer Scotland unless you expressly state otherwise on your application for such Raffle Ticket(s), for example by emailing the Raffle Tickets numbers and your details you received from Alzheimer Scotland when you purchased the tickets online. If payment is received after the Closing Date, Raffle Tickets will not be purchased/ entered into the Bathroom Raffle 2021.

- 28. Alzheimer Scotland reserves the right to withhold or refuse payment of any Prize if Alzheimer Scotland has reasonable grounds to believe that these terms and conditions have been breached in any way.
- 29. If a Prize is transferred to a person who is not eligible to receive the Prize, the Prize shall be repayable or returned (as applicable) by that person to Alzheimer Scotland on demand.

### **Limitation of Liability**

- a) to any person for Alzheimer Scotland inability to contact you and/or award any Prize due to any errors or omissions in the details you provide or your failure to update these details if they change:
- b) for any interest of whatever nature claimed by person in a lost or stolen Raffle Ticket
  - c) any matter beyond Alzheimer Scotland reasonable control.
- 40. Nothing in these terms and conditions shall exclude or limit the liability of Alzheimer Scotland for:
  - a) death or personal injury resulting from negligence;
  - b) fraud or fraudulent misrepresentation; or
  - c) any other liability that cannot be excluded or limited by law.
